The Proceedings of the First Finance Committee Meeting.

The First Finance Committee Meeting was convened on 11th May 2022 at 11.30 AM. On the Oral request of the Committee members the meeting was preponed to 10.30 AM on the same day, at the Conference Hall on the first floor of Faculty Block in the University.

Following are the proceedings of the meeting:

Subject No 1: Approval of Annual Accounts for the Financial years 2017 - 18 to 2019-20.

Decision: The Annual accounts for the financial years 2017-18 to 2019-20 were ratified and approved by the committee.

Subject No 2: The Statutory Audit report of Dr B R Ambedkar School of Economics University for the Financial years 2017 - 18 to 2019-20.

Decision: After going through the Statutory Audit report of Dr B R Ambedkar School of Economics University for the Financial years 2017-18 to 2019-20, received from Additional Controller, Bangalore Regional Office, State Audit & Accounts Department, the Committee with respect to objections and recoveries, recommended to collect the replies with supporting documents from all the concerned sections and consolidate them for submitting to Government and Statutory Auditors.

Subject No 3: Appointment of Chartered Accountants for the Financial Year 2021-22.

Decision: The Committee after discussion approved to appoint Chartered Accountants for the Financial Year 2021-22, after calling for quotations.



Subject No 4: Joint Signature of Vice Chancellor and Finance Officer for Cheques.

Decision: The Committee after discussing the Government Order No: FD 5 TAR 2017, detect 30-01-2017 and ED UBV 2021 dated 14-2-2022, recommended to implement the system of issuing cheques with Joint signatures of Vice Chancellor and Finance Officer.

Subject No 5: Submission of Budget for the year 2022-23.

Decision: The Committee after discussion approved the Budget estimates for the financial year 2022-23. As per Dr B R Ambedkar School of Economics University Act, 40(1), after scrutiny of the Budget by the Finance Committee it is required to be submitted to Executive Council of the University for Approval. The Council is yet to be constituted. As per the letter of Office of the Governor No. GS 01 EUM 2021 dated 06-02-2021 and as per Dr B R Ambedkar School of Economics University Act, 44, the Vice Chancellor has been delegated full powers. The Vice Chancellor approved the Budget.

Other Subjects:

Subject No 1: Interior works undertaken at the Visual Arts Center in Bangalore University, Rajaji Hall Building, by Karnataka Housing Board.

Decision: As per the letter from the University No BASE/FIN/023/2019 dated 18-07-2019 it was proposed to meet the expenditures relating to the above work out of the interest earned from the deposits made to KHB. As KHB has not agreed to the above proposal, the committee decided that after the completion of all the works at the University and after receipt of third-party inspection report, necessary action may be taken in this regard.

With the approval of the Chair, following additional agenda were taken for discussion:

Subject No 1: Creation of Additional Non-Teaching posts and the financial implication there on.

Decision: During 2018 the Government sanctioned only 11 teaching and 12 non teaching posts. In order to run the Institution smoothly a proposal was sent to Government on 12-4-2022 vide letter BASE/87/2017 requesting for the creation and sanction on 123 Nonteaching posts in addition to 12 sanctioned posts. An additional financial requirement of ₹ 5.88 Crores was sought in this connection. This proposal was ratified by the Finance Committee.

Subject No 2: Payment of Consolidated Pay to Ad-hoc teaching faculty.

Decision: It was proposed and agreed for an increase of 5% on the previous pay drawn when the appointments of Ad-hoc teaching faculty are renewed (with a break of 7 days) for a further period of 11 months. The matter was to be placed before the Governing Council for ratification (Ref. File No.BASE/27/2020). Since the Governing Council ceases to exist consequent to establishment of the Act, it was brought to finance committee for ratification and after discussion the Finance Committee ratified the above proposal.

Subject No 3: Payment of Home-orderly allowance to the Vice-Chancellor, Registrar and

Decision: After discussion the committee recommended and approved to follow the practice that is followed at The Bangalore Central University for the payment of Home orderly allowance to Vice Chancellor, Registrar and Finance Officer amounting to ₹7,000, ₹6000 and ₹3000 respectively with retrospective effect.

Subject No 4: Payment of sitting fee to the members of different Committees.

Decision: After the discussion the committee approved the sitting fees as follows:
