Preamble

Whereas the Hon'ble Supreme Court of India, in it's judgement pronounced in case of of Vishaka v/s State of Rajasthan, during 1997, laid down guidelines to be followed by institutions in dealing with complaints about sexual harassment which were to be followed till a legislation is passed to enact required laws. The SAKSHAM COMMITTEE appointed by the UGC made a comprehensive study of issues involved and recommended guidelines to be followed by a University , for ensuring safety of women and students for gender sensitization on Campus.

Whereas the University Grants Commission has notified regulations 2013 1nd 2015 towards prevention, prohibition and redressal of sexual harassment of women employees and students in higher educational institutions, in India, a grievance redressal mechanism, procedures, process of making complaints ,conducting enquiry, punishment, compensation and consequences of noncompliance et., which are binding on Universities and is mandated to be created for gender sensitization against sexual harassment.

Consequently, University has constituted Gender Sensitization Committee against Sexual Harassment vide notification dated 27th January 2023. However, the said committee needs to be re constituted in view of few developments including UGC communications dated cited at ref. no. 5 above.

Hence in pursuance of the said developments, following is notified:

NOTIFICATION

In partial modification of University notification dated 27th January 2023, as part of grievance redressal mechanism, a Gender Sensitization Committee against Sexual Harassment (GSCASH) or Internal Complaints Committee (ICC) or a committee for prevention of Sexual harrassment is herewith constituted, as under:

The students' representatives on the Committee cited at 6 to 8, , shall be part of the Internal Complaints Committee, if the matter involves students.

The term of office of the members of the ICC (excluding students' representatives), shall be for a period three years. The membership of students, shall be co terminus with their studentship status or three years, whichever is earlier.

The I C C shall follow strictly the recommendations of SAKSHAM committee and regulations notified by the UGC dated 2^{nd} May 2016, and communications dtd 5^{th} and 20^{th} June 2023 and issued from time to time, in discharging it's duties, responsibilities and compliances issues.
