## NOTIFICATION

### **PREAMBLE:**

Whereas State of Karnataka through an Act of Legislature, has established Dr. B R Ambedkar School of Economics University Act, 2018. The said University came to be established from 30<sup>th</sup> October 2019.

Whereas under Section 20 of the Act, many bodies are declared to be the Authorities of the University. These Authorities are empowered to manage the academic, administrative and financial affairs of the University and responsible for orderly functioning of the University.

Whereas under Sec.13(6) of the Act, the first Vice Chancellor of the University has been appointed by the Government of Karnataka. Under S.44 of the Act, the Chancellor of the University and the Governor of Karnataka, vide letter dated 6<sup>th</sup> Feb 2021, has permitted the Vice Chancellor, to discharge all or any of the functions, exercise any powers or perform duties exercised by any authorities, until such Authority comes into existence.

Whereas under Sec.29 of the Act, the University may establish such other Boards, Committees and Councils as may be specified in the Schedule. Sub Sec.1 of the said Schedule enables the Executive Council, by resolution, constitute such Standing Committees or appoint Ad-hoc Committees for exercising any power, enquiring into, reporting or advising upon any matter relating to the University.

Whereas the University has been recently started and it needs to be strengthened both administratively and academically, it is felt expedient to constitute an Ad-hoc committee to examine and advise the University, on the following matters:

- i. Framing of Statutes
- ii. To frame rules, regulations and ordinances
- iii. To suggest measures for setting up administrative system and examination related issues.
- iv. To analyse, assess and recommend existing human resources including additional posts
- v. Any other issue/s which require immediate attention for speedy action.

### **Hence this notification:**

Under Sections 29, 44 and Clause1 of the Schedule of the Dr.B.R. Ambedkar School of Economics University Act, 2018, the Vice Chancellor is pleased to constitute an Ad-hoc committee consisting of the following eminent educationists/administrators, to examine and advise the University on different issues mentioned above:
