### NOTIFICATION

**Sub:** Regulations on Curbing the Menace of Ragging in Higher Educational Institutions in University: Constitution of Anti Ragging Committee

**Read:** 1. Judgement of Hon'ble Supreme Court of India in case/s of University of Kerala v/s Council, Principals, colleges and others in SLP No. 24295 of 2006 dated 16.05.2007 and that dated 8.5.2009 in Civil Appeal number 887 of 2009

2. UGC Regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2009, notified vide it's notification no. F.1-16/2007(CPP-II) Dated 17th June, 2009.

#### Preamble:-

Whereas , In view of the directions of the Hon'ble Supreme Court in the matter of University of Kerala v/s Council, Principals, colleges and others" in S L P No. 24295 of 2006 dated 16.05.2007 and that dated 8.5.2009 in Civil Appeal number 887 of 2009, and in consideration of the determination of the Central Government, the University Grants Commission have taken steps to prohibit, prevent and eliminate the scourge of ragging including any conduct by any student or students whether by words spoken or written or by act , and thereby, to provide for the healthy development, physically and psychologically, of all students, in all higher education institutions including Universities in the country.

Whereas the Commission notified regulations called the "UGC Regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2009", vide it's notification no. F.1-16/2007(CPP-II) Dated 17th June, 2009. The regulations notified by the University Grants Commission, inter-alia, define what acts/actions are construed/constitutes ragging and action to be initiated by Higher Educational Institutions including Universities. They also include responsive action including reporting of the incidents of ragging and holding of inquiry to examine the said issues allegedly committed by student or group of students against a student or group of students in the University. The said regulations provide for other administrative actions to be taken by the University, depending on the facts of each incident of ragging nature and gravity of the incident of ragging established, including reporting to appropriate authorities. The University is contemplating to constitute appropriate forums like ANTI RAGGING SQUAD and ANTI RAGGING COMMITTEE at the University level to probe, inquire, decide, recommend / award appropriate punishment/s to delinquent student/s and forum for appeal against punishment awarded.

Whereas the Commission has been updating the said regulations from time to time, including additions and amendments also.

The University is committed to framing of a formal statute for implementing the regulations notified by the UGC, as per Section 30 of the Dr. B R Ambedkar School of Economics University, Bengaluru Act 2018. Hence in pursuance of the resolve and measures mentioned in foregoing paras, following is notified:

In pursuance of the UGC regulations No. F.1-16/2007(CPP-II) Dated 17th June, 2009 as amended from time to time and pending framing of a Statute under Section 30 of the Act, as a part of establishing an anti-ragging ( redressal ) mechanism, an ANTI RAGGING COMMITTEE (ARC) in Dr. B R Ambedkar School of Economics University, Bengaluru, is herewith constituted, as under:



The term of office of the members of the anti ragging committee shall be for a period three years.

The Committee shall strictly follow the regulations notified by the U.G.C. bearing No. . F.1-16/2007(CPP-II) Dated 17th June, 2009 and as amended from time to time in discharging it's duties, responsibilities, functions and follow up of procedures and compliance issues.
