Subject: Code of Conduct and Discipline among Students - Constitution of
DISCIPLINARY COMMITTEE

Dr. B R Ambedkar School of Economics University, is offering different academic programmes on full time basis on fully residential basis. Students enrolled for these programmes, are expected to stay within the premises of the University in the hostels maintained by it. They are provided with adequate extra and co-curricular activities along with their academic pursuits. In order ensure peace, harmony and right ambience during their stay, University has been issuing many guidelines /code of conduct regulating their behaviour/activities to secure peaceful co-operation/co-existence among the entire student community on the campus and to afford reasonably comfortable and peaceful stay to all students of University.

University has already notified hostel rules regulating their conditions of stay, adherence to them and consequential disciplinary issues in case of violation by a student/s or group of students. These rules regulate their authorised movement within and outside the campus area, restrictions and consequences of violations if any also. These rules which are notified vide notification dated 27th October 2022 clearly states the status of visitors of Students., general code of conduct and strictly prohibited acts in the campus and ultimately the issue of penalties/punishment on delinquent students. They have been sent to all students by mail, hostel notice boards and hosted on public domain of University.

Students are the torch bearers of cultured society and polished behaviour, which binds them all as one large family. They are to follow the limitations imposed on them, to secure a calm, peaceful and harmonious atmosphere, to cherish their stay and achieve academic excellence. Perhaps students do agree, that University is responsible for their upkeep till they walk out of the gates after graduation.

However few stray acts by stray student/s of misconduct and indiscipline, has come to the notice of the University, which necessitates reiterating of the responsibilities of students to secure peaceful harmony on the campus. As part of the code of conduct and in order to provide a redressal mechanism for the purpose of inquiring and investigating into such complaints of misconduct and indiscipline, the Vice Chancellor has been pleased to constitute a Disciplinary Committee for the said purpose, consisting of the following:

The warden of the Hostel where the concerned student is a boarder, shall be an invitee for the relevant meetings of Disciplinary Committee

The chairperson may invite any other person/s who is not a member but whose presence is necessary, for disposing any case/ matter on hand.

2/3rd of the committee members would form a quorum for holding the meetings of the committee and discharging its functions.

The Disciplinary Committee will follow procedures laid down in examining the complaint received against a student/s. It will inquire/investigate into a complain/s received by it from concerned, consider them, afford adequate opportunities to the concerned for being heard, seek inputs from concerned, deliberate and ultimately submit its report not later than 15 working days along with its findings, whether the concerned is found guilty or not, to the VC/Registrar/Dean of the Faculty.
