1. ELIGIBILITY:

(a) <u>5 year Integrated M.Sc. Economics as per SEP 75 seats for Indian candidates + 5 seats for PIO/FN],:</u>

Candidate should have completed 2nd PUC/ 12th Std./ Equivalent Exam with English as one of the Languages and Mathematics as a core subject and obtained a minimum of 65% marks in aggregate (60% for SC/ST category students).

(b) <u>2 year M.Sc. Economics [30 seats for Indian candidates + 5 seats for PIO/FN] and 2 year M.Sc. Financial Economics [30 seats for Indian candidates + 5 seats for PIO/FN]:</u>

Candidates should have completed B.Sc./B.A (Honours) in Economics or B.Sc./ B.A in Economics with Mathematics and Statistics/Econometrics as major courses in the degree with minimum of 55% (50% for SC/ST) in aggregate or B.Sc./B.A Economics with atleast 2 papers of Mathematics [for Economics] and 2 papers of Statistics [for Economics]/ Econometrics with Mathematics as a core subject in 2nd PUC/12th standard/10+2/ Equivalent Examination with minimum of 55% (50% for SC/ST) in aggregate.

2. Selection Procedure:

- (a) Based on performance in CUET-2025 (Common University Entrance Test) conducted by National Testing Agency (NTA) for 5 year Integrated M.Sc. Economics as per SEP, 2- year M.Sc. Economics and 2-year M.Sc. Financial Economics Course as well as the University Admission advertisement 2025-26, Provisional merit list will be prepared based on marks secured in the entrance **test pattern** English and General Test only in CUET 2025 in case of UG and by considering test paper code no. COQP10 in CUET-2025 in case of PG:
- (b)For PIO/ Foreign Nationals admission is based on the merit list of the performance in the respective qualifying examination. Appearance for CUET-2025 is not compulsory.
- (c) If any seats remain unfilled under 'Karnataka Category', such seats will be converted to 'All States including Karnataka Category and vice-versa. While converting Karnataka category to All State category, first preference will be given to All State Candidates who have resided for not less than Ten years in Karnataka subject to producing domicile certificate.

Admissions offered will be confirmed subject to physical verification of documents relating to eligibility criteria.

The following admission eligibility list will be prepared by the University on the basis of Online Entrance Test (CUET-PG) Score secured in question paper code COQP10 in CUET 2025, Eligibility criteria and as per the reservation roster. Merit list will be published on the University website www.base.ac.in.

- (c) Kalyana Karnataka (H-K/371(J)) candidates merit list.
- **Note:** 1. The admission will remain provisional until the physical verification of original documents indicating that the candidate has met the eligibility criteria.
 - 2. In case the candidate do not indicate their acceptance within the stipulated deadline, the provisional offer stands cancelled.
