Objectives:

1. The IQAC shall develop a system for timely conscious, consistent, efficient and catalytic programmed action to improve the academic, administrative performance of the University
2. The IQAC shall promote measures for institutional functioning towards quality enhancement through internalization of quality culture and institutionalization of best practices in the University.

Strategies:

1. The IQAC shall evolve mechanism and procedures required to plan, guide and monitor Quality Assurance and Quality Enhancement activities of the University.
2. It shall evolve mechanism and procedures and take timely, efficient and progressive steps, required to be facilitative and participative organ of University and channelize /systematise efforts and measures towards administrative and financial tasks and academic excellence ,

3. It shall become a driving force for ushering in quality by working out intervention strategies to remove deficiencies, enhance quality and credibility of assessment and evaluation process.
4. It shall evolve mechanism and procedures for optimization and integration of modern methods of teaching and learning.


Functions: It shall function and be guided in accordance with the updated guidelines issued by the UGC, New Delhi and NAAC, Bengaluru, issued from time to time.

Term: The membership of the IQAC, shall be for a period of TWO years and co terminus with the position held by them, whichever occurs earlier. Non official members are eligible for sitting fee and TA (if any) as approved by the Finance Committee.

Meetings: It shall meet as and when necessary but atleast ONCE in a quarter.

Quorum: The quorum for the meeting shall be TWO THIRD of the total number of members of the cell.
