NOTIFICATION

Sub: Regulations on Curbing the Menace of Ragging in Higher Educational Institutions in University. Reconstitution of Anti Ragging Squad in the University

Ref: 1. UGC Regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2009, notified vide its notification no. F.1-16/2007(CPP-II) Dated 17th June, 2009.

2. University notifications of even number dated 1st March, 19th May and 29-08-2023.

3. Approval of the Hon'ble Vice-Chancellor dated: 25-02-2025.

Preamble:

Whereas, In pursuance of UGC Regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2000, vide its notification no. F.1-16/2007(CPP-II) Dated 17th June, 2009, the University has taken steps to prohibit, prevent and eliminate the scourge of ragging including any conduct by any student or students whether by words spoken or written or by act, and thereby, to provide for the healthy development physical and psychological, of all students, in Dr. B. R Ambedkar School of Economics University, Bengaluru.

As required, vide notifications cited at ref no. 3, it has taken other responsive and administrative steps including reporting of the incidents of ragging, nature, gravity and holding of inquiry to examine the said issues allegedly committed by student or group of students against a student or group of students in the University. It has constituted an independent ANTI RAGGING COMMITTEE consisting of representatives of students to probe, inquire, decide, recommend/award appropriate punishment/s to delinquent student/s,

As a part of establishing an anti-ragging (redressal) mechanism, and in continuation of the said anti ragging committee, an ANTI RAGGING SQUAD is constituted for maintaining vigil, oversight and patrolling functions and which shall remain mobile, alert and active at all times on the campus. in Dr. B. R Ambedkar School of Economics University, Bengaluru consisting of the following as under:

The member Secretary shall interact with Squad Chief in the work of squad, regularly. The Assistant Warden of the Hostels concerned, shall assist the squad in discharging it's duties and responsibilities.

The term of office of the members of the anti-ragging squad shall be for a period three years.

The squad is empowered to make surprise visits to hostels and other common areas vulnerable to incidents of and having the potential of ragging.

The squad shall also conduct an on-the-spot enquiry into any incident of ragging referred to it by the University including faculty, staff, student, parent, guardian, employee or any other person. The Squad shall conduct such enquiry as necessary, observing a fair and transparent procedures and affording principles of natural justice and after giving adequate opportunity to the student or students accused of ragging and other witnesses, to place before it the facts, documents and views concerning the incident of ragging, and considering such other relevant information as may be required. The anti-ragging squad shall submit it's enquiry report along with its recommendations, to the Anti Ragging Committee for further action.

The squad shall strictly follow the regulations notified by the U.G.C. bearing No. F.1-16/2007(CPP-II) Dated 17th June, 2009 and as amended from time to time in discharging it's duties, responsibilities, functions and follow up of procedures and compliance issues.
